Earlier today, I received an email from Heather Haller with Sherburne County:

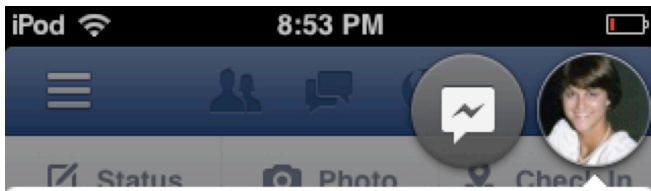
"I checked with our Court Administration and they do now show anything for you in regards to a Harassment Restraining Order or an Order for Protection. Our court checked statewide and found nothing. If someone in our county had applied for a Harassment Restraining Order or an Order for Protection against you and it was granted the Sheriff's office would receive the paperwork to have you served. We do not have anything in our database for you either. If someone was to get an order against you in Minnesota we would forward the paperwork to the local law enforcement agency in the area where you reside and you would have to be personally served the documents by your local sheriff's office."

I am hereby requesting, by August 12, 2013 at 5pm, a copy of the restraining order that you claim was in effect on July 3, 2013.
