regarding a relationship that she had with Father Anthony Oelrich, a priest in the St. Cloud Diocese. was advised to contact the St. Cloud Police Department and make a report. I met with on two occasions and a formal statement was taken on 08/22/06, at 1622 hours.

advised that in the early 1990's, she

During that time, Father

Tony Oelrich, a newly ordained priest, was assigned as an associate pastor at Sacred Heart Catholic Church, Sauk Rapids.

She and Father Tony became friends and Father Tony told her that he was in love with another woman. said that Father Tony confided in her and trusted her. stated she was very honored that Father Tony, who seemed "very holy and a compassionate priest" would trust her. describes Father Tony as a

shepherd of the people, anointed and therefore, "set apart for God's service".

confided in Father Tony that she and vere having marital issues. stated Father Tony counseled her and listened to her when she spoke of her alcoholic abusive husband. Father Tony told that God thinks she is precious and that God doesn't want her to hurt. She believes that Father Tony should have told her to come to the rectory to be counseled and to talk about work issues, instead Father Tony often went to her home.

In the spring of 1993, Father Tony was at her house for lunch, which was not uncommon, and he kissed her. In the summer of 1993, knowing was gone; Father Tony came to her house and had sexual intercourse with her. stated she wasn't physically forced, but knew it was inappropriate because she was married, she was confiding and counseling with Father Tony and because he is a priest.

As she and were going through their marital issues and divorce, became suspicious of a relationship that may have been going on between her and Father Tony, made a report to the St. Cloud Diocese and she was contacted to meet with the diocese that was represented by four priests, including Father Tony, advised that she was ultimately questioned and/or accused of seducing Father Tony.

In December 1995, and divorce was final. In 1996, Father Tony introduced her to who she eventually married. Father Tony officiated their wedding. One of the scripture readings

was "love is forgiving, love is never boastful" etc. stated that Father Tony wrote her his version of those promises towards her. A copy will be attached to this case file.

stated that Father Tony wrote her many letter and sent many cards. When Father Tony found out she still had them, he drove to pick her up, drove her to where the letters were stored at her and then drove her to a dumpster, where he made her throw them away.

described several sexual encounters with Father Tony. I was able to ascertain the incidents to have occurred in Sauk Rapids, at Father Tony's home, the rectory at Sacred Heart Church (Benton County), Stillwater, at a hotel, (Washington County), Maple Grove, at a hotel, (Hennepin County), Brooklyn Center, at (Hennepin County), and (Pine County). knows that there was a time they pulled off into a parking lot in St. Cloud, on the west side of the Mississippi River, (Stearns County) but she does not know the exact location.

Father Tony was sent to Rome in 2001. stated that since Father Tony returned from Rome, in 2005, the physical contact stopped.

Father Tony and maintained a relationship/friendship to include family vacations and written correspondence. A copy of the written letters and printed text messages will be attached to this case file.

is concerned because she knows Father Tony has been sent away for therapy. Father Tony is currently assigned to the Newman Center and has had, and to the best of her knowledge, continues to have, inappropriate sexual relationships with at least four other woman.

advised that she was being emotionally and spiritually manipulated as she was afraid to lose Father Tony's support because she felt frightened and alone.

advised that Father Tony bought her gifts and made her feel special and loved.

described Father Tony as "The voice of God to me."

shared that she confessed her sin to Father Tony, in a confessional setting, hoping the sexual intercourse would stop.

stated that Father Tony told her that God knows they are doing their best and understands that they love each other.

provided documentation including her chronological time line, copies of numerous cards and text messages that she had from the last several years from Father Tony. I read through all the information and found in a text message, dated 07/01/16, at 0745 hours, from Father Tony a sentence as it relates to "My stupidity in the confessional" and how painful it is to him. In another text message, dated 07/02/16, at 2217 hours, from a comment is made regarding her possibly counseling Father Tony. All information will be attached to this case file.

stated she was not going to report this to the police, but found out that Father Tony was doing this to other woman and she wants it to stop. Those cases will be investigated separately.

She also felt flattered because Father Tony trusted her and saw wisdom in her. described that Father Tony would stand so close behind her, as and that his body would touch the back of her body. She felt he would invade her personal space. described times that Father Tony would smell her hair, touch her arm, or just be in her personal space.

She advised that early in their friendship, Father Tony alluded to inappropriate sexual behavior that he had in his past. She interpreted this as him saying that it was okay if the two of them had a relationship. advised Father Tony she did not want to know about that behavior and felt it was none of her business. To this date she does not know any details. admits that she was flattered by his attention and trustworthiness.

During this discussion, Father Tony stated he thought that someday they could, and cut him off immediately and forcefully stated no. stated Father Tony never finished his sentence, but she felt he was going to say that they could be together or have a sexual relationship. There was sexual tension between the two of them, and she felt as though Father Tony wanted to take it to the next level, and she very outwardly advised him that was not going to happen. That conversation ended with a hug and Father Tony kissing her on her face. Since that conversation, the relationship between her and Father Tony has completely changed, and he has disregarded her and treated her very poorly including This made contact and talk with anyone who would listen including her husband. and friends to try and figure out if this was okay.
